Panel 1: PANEL 1 European labour market trends and the future of work – implications for social protection systems?



Paul DE BEER is Professor of Industrial Relations at the University of Amsterdam (UvA). Het is affiliated with the interdisciplinary research institute AIAS-HSI at the UvA and also director of the Scientific Bureau for the Dutch Trade Union Movement, De Burcht. His research interests include industrial relations, labour market developments, social policy and solidarity.



Ana Carla PEREIRA is Head of Unit for "Modernisation of social protection systems" in Directorate General Employment, Social Affairs and Inclusion at the European Commission. She is responsible for social protection policies related to access and adequacy of pensions, long-term care and health. She is currently coordinating the work around the initiative "access to social protection", one of the concrete deliverables of the European Pillar of Social Rights. Prior to this, she was responsible for skills and qualifications policies, including the New Skills Agenda for Europe. She has also worked more than ten years on the implementation of European

Employment Strategy and several years in the private sector as a business consultant specialised in human performance. She graduated in Economics at University of Coimbra (PT) and holds a MA in European Human Resources Studies from the College of Europe (BE). She speaks Portuguese as a mother tongue and is fluent in English, French and Italian.



Chloé TOUZET is a policy analyst at the Directorate for Employment, Labour and Social Affairs of the OECD. She is also affiliated to the University of Oxford and to LIEPP Sciences Po. She works on issues of social policy and collective bargaining in OECD countries.



Since 2002 **Anne-Sophie PARENT** is Secretary General of AGE Platform Europe (AGE), a network of 110 organisations representing some 40 million seniors across Europe in 27 EU. Ms. Parent is a member of the High-Level Group on Pensions and sits in the Euro Retail Payment Board of the European Central Bank. She also chairs the Financial Services Users' Group set up by the European Commission.



Theo LANGEJAN has had a long career within the Public Service before joining the private sector as a consultant. In the Public Service Theo Langejan has, as a Director General in the Ministry for Social Affairs, been responsible for developing the regulatory framework for second pillar pensions in the Netherlands. In the Ministry of Finance, he has been responsible for Tax Legislation. Theo Langejan has been chairman of the European Social Protection Committee for 2 years, on a national

level he chaired the so called "Parameter" commission that developed the Dutch UFR to be used to discount pension liabilities.

In 2017 Theo Langejan joined the Federation of Dutch Pension Funds to help develop a new pension contract, and since 2019 he also leads the Brussels office of the Federation of Dutch Pension Funds.

She has published on matters related to old age pensions and social protection floors and was part of the team that worked on the development and follow-up of the Social Protection Floors Recommendation (R.202). She is currently responsible for ILO work on the Global Partnership for Universal Social Protection to Achieve the Sustainable Development Goals (<u>USP2030</u>), the development Interagency Social Protection Assessment (<u>ISPA</u>) Tools and the ILO support to the UN Joint SDG Fund.

Panel 2: Re-thinking the existing models for social change - how to deliver sustainable and modern social protection?
