Earl POMEROY, Former Congressman & Alston & Bird LLP – the US

Former Congressman Earl Pomeroy brings 26 years of regulatory and legislative experience to his present position as senior counsel at Alston & Bird LLP.

Mr. Pomeroy's practice focuses on matters before the legislative and executive branches of government at the federal level as well as work before financial regulators at the state government level.

Mr. Pomeroy has been an influential participant in financial services regulation as it has evolved over the last quarter century. More than twenty years ago, as President of the National Association of Insurance

Commissioners, he advanced reforms to strengthen solvency oversight in state insurance departments which were widely adopted, substantially improving the quality of state insurance regulation.

For eight terms he was the only member of the U.S. House to have served as an Insurance Commissioner.

This unique background provided the basis and credibility for Pomeroy's active participation in regulatory reform debates held throughout his time in Congress.

Drawing upon his background as North Dakota Insurance Commissioner, President of the National Association of Insurance Commissioners, nine term Member of Congress and senior member of the House Ways and Means Committee, Pomeroy's practice areas include financial services regulation, health care policy, pensions, tax policy, energy and agriculture.

Bertrand BOIVIN-CHAMPEAUX, Director – French Technical Centre of Provident Institutions, CTIP - France

Graduated from of a French Business School in Paris (ISG) and qualified as a Chartered accountant in 1999, Bertrand BOIVIN-CHAMPEAUX is an expert regarding financial and actuarial regulations for insurance and pension industry, as well as for social welfare programs.

For ten years, he worked in an audit firm (PwC), in financial services, where he was in charge of a portfolio of French and European insurance companies and mutuals.

In 2003, he joined the CTIP, the professional association of paritarian insurers (covering 13 millions of employees, with € 184 billion in assets and a turnover of € 27 billions) where is appointed as a Head of Insurance & Pension Unit. He advocates in France for workplace health insurance plans and occupational pensions funds. He participates to negotiations with the French government regarding new regulations for pensions, healthcare and long term care activities, but also regarding insurance regulation. He was actively involved in the Solvency II negotiations at a French and European level from 2008 to 2016 and now takes part in the European negotiations for the Review of Solvency 2. He has negotiated the new tax framework for paritarian insurers implemented in 2012.

He is a member of working groups of the French Accountancy Authority (ANC) and participates to working groups of the French Association of Actuaries. He is also a member of the French High level Expert Group on Ageing (HCFEA) since December 2016 and of the High Committee of the Financial Sector (CCSF) since 2014. He is appointed as Secretary General of the National Guarantee Fund for Paritarian Insurers since 2006.



Mariah BECKER, Director of Research and Education, NCCMP – the US

Mariah Becker joined the NCCMP in 2016 as the Director of Research and Education. Prior to joining the NCCMP, Mariah provided actuarial consulting to single and multiemployer benefit programs for 15 years. Mariah spent 10 years with Segal Consulting, focusing on multiemployer defined benefit pension plans. While at Segal, she worked with clients to assess their funded position and to develop strategies for improving funding levels, while balancing stakeholder

concerns and the changing legal landscape. She also advised on other issues including actuarial projections of funded status, plan design and cost studies, mergers, and withdrawal liability. Mariah brings a strong understanding of the actuarial issues facing a broad range of multiemployer defined







benefit plans in a range of industries, from large national multiemployer plans to smaller local plans and union staff plans.

In the course of her work with Segal Consulting, Mariah worked closely with the NCCMP on the review and design of legislation affecting the multiemployer plan community and participated in the Retirement Security Review Commission, convened by the NCCMP to consider challenges and potential solutions facing multiemployer pension plans as described in "Solutions Not Bailouts." Since its publication, Mariah assisted in analyzing the recommendations resulting from that Commission, including analysis and stress testing of the new proposed composite plan design.

Mariah graduated *magna cum laude* from Colgate University with a BA in Physics-Astronomy. Prior to her work with Segal Consulting, she worked with another major actuarial consulting firm focusing on defined benefit pension plans. She is a Member of the American Academy of Actuaries, an Enrolled Actuary, and an Associate of the Conference of Consulting Actuaries.

PGGM is a Dutch pension service provider, working for multiple pension funds, with €218 bln assets under management and working for 3.0 million participants. PGGM is a cooperative with 725.000 members, an association for people who works or have worked in health care or social services.

Frido is responsible for the PGGM's cooperative principles, the societal agenda of PGGM and the corporate social responsibility program. He is also a board member of the Cooperative WeHelpen, Deltaplan Dementia (a nationwide program to fight Alzheimer's disease), chairs the group The Caring City and chairs an international working group on the role of money and finance in the transition to a circular economy.

These topics, together with various other specific initiatives/projects, are also addressed in the EU Social Dialogue committee for the construction industry in which FIEC represents the employers.



Werner Buelen, European Secretary Construction, the European Federation of Building and Woodworkers, EFBWW – Belgium

Werner Buelen is European Secretary in the European Trade Union Federation for the Construction and Wood sectors, where he devotes 90 percent of his practice to coordinate the European trade union activities for the construction industry for the last seventeen years. He has extensive experience in the complex EU decision making process and influencing policy makers. As the EFBWW is recognized as the European sectoral social partner representing the interests of the workers, Werner also coordinates the workers' interests in the intensive EU social dialogue for the construction industry with the European Employers counterpart. At the

same time he coordinates various EU projects.

Liina Carr, Confederal Secretary, European Trade Union Confederation, ETUC – Belgium

Liina Carr was elected Confederal Secretary of the ETUC at its Paris Congress in October 2015. Before joining the ETUC leadership team — an organisation representing at European Union level 45 million members of 89 trade union organisations in 39 European countries - Liina was International Secretary of the Confederation of Estonian Trade Unions (EAKL) for over 10 years.

She has a Masters degree in Law, has studied and worked in the UK as well as in Estonia, and has been a member of the European Economic and Social Committee (EESC) since 2004. She has worked in the academic, NGO and private sectors.
