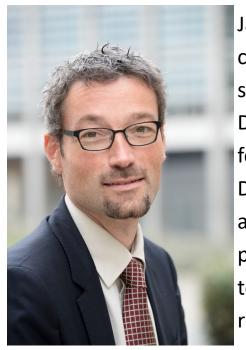




Nina Bruun has more than 20 years of experience in the pension industry. She has worked in several different positions at the Finnish pension company Ilmarinen. Such as coaching pension specialists and developing the implementation of the pension system and its information systems. She has worked both as a pension director responsible for pension, and in her current position as a Director responsible for managing the development of pension services for retiring and insurance customers.



Jan Ceyssens is Head of the "Digital Finance" Unit in the Directorate General for Financial Stability, Financial Services and Capital Markets Union at the European Commission. He was previously Member and Deputy Head of the Cabinet of Vice President Dombrovskis and Member of the Cabinet of Vice-President Barnier, and Team Leader for Financial Supervision at the European Commission's Internal Markets and Services Directorate General. He graduated in law from Humboldt University in Berlin and holds a Masters degree in European Law from King's College London. He works at the European Commission since 2006, initially in the Directorate General for Competition's Cartels enforcement Directorate and since 2009 in the Internal Markets and Services Directorate General.



Dr. Job Krijnen is a senior behavioral researcher at the Dutch Authority for the Financial Markets (AFM). He applies psychological insights to supervision and policy on financial products, information, and choice architecture. He has a specific focus on pensions and has contributed to the AFM's preparation for ongoing pension reforms in the Netherlands. He obtained his PhD at Tilburg University in the Netherlands, studying the effects of pension communication on inertia and procrastination. Between 2016 and 2019 he worked as a postdoctoral scholar at UCLA in Los Angeles, where he focused on the topics of choice architecture and policy communication.



Mark joined the Pensions and Lifetime Savings Association in March 2019, is responsible for media relations and public affairs, and is a regular spokesperson on the association's saver-facing initiatives including the nation-wide Pay Your Pension Some Attention awareness campaign. Claudia Wegner-Wahnschaffe, is Head of International, ETS Association, at Supplementary Pension Fund of the German Federation and States, VBL. Wegner-Wahnschaffe started her career in the litigation department of the Supplementary Pension Institution of the German Federation and the States, VBL. She changed to the VBL Board Department as an adviser on strategical, associational and European matters and has been working as Head of International and Association Activities for the VBL since 2009. She was appointed as member of the EIOPA Expert Group on Pension Tracking in 2021 and is furthermore a member of one of the stakeholder groups of the German Agency running the Digital Pension Overview. Wegner-Wahnschaffe graduated as a fully qualified lawyer in 1995.
